# 9. OPP Report

Quarterly Report (January – March 2024)

Inspector Neufeld provided an update and noted that the year-to-date billing summary is similar to the previous year but with a slight increase year-to-date of Weighted Hours. He reviewed the report and highlighted areas of change and the possible reasons for the change in calls for service. He indicated that there has been a spike in mental health calls for service which has resulted in a significant response and due to ongoing issues in the community. The OPP are working with the County of Renfrew paramedics and are continuing with foot patrols with increased police presence in the more problematic areas. There were no public complaints or requests for secondary employment during this quarter. He provided an update on the Collision Reporting Centre and a recent meeting held with the City's By-law Enforcement Services. He thanked Mr. Fred Blackstein and the City for the great day held on May 1<sup>st</sup> with the dedication of First Responders Way and he confirmed that the Golden Helmets will be in Pembroke on September 21<sup>st</sup>.

#### 10. New Business

a. School Zone Safety

Mr. Lewis circulated and presented his report. A discussion was held, and it was suggested that the Board include pedestrian safety in its monthly PSAs.

b. Operations Department Update

Mr. Lewis provided a verbal update of items the Operations Department is currently working on.

c. Email Concern – Mary Street/Trafalgar Road Intersection

The Chair reviewed the report. It was noted that an OPP Directed Patrol was initiated in the area over 3 days which resulted in zero violations.

d. Pembroke Community Expo

Email – Foot Patrols March 28, 2024

Detective Richie Downing was present at the meeting and indicated that the current cameras in the downtown area are approximately 6 years old and stated that there are drawbacks with the older technology. He stated that newer technology would be helpful. He also indicated that all existing security cameras that the OPP are aware of are registered with CAMSafe.
